Be it enacted by the Town of Wellington:

Ordinance Concerning Donations in the Town of Wellington

WHEREAS Wellington revenue comes from taxpayers, and
WHEREAS, government cannot give to one without taking from another; and
WHEREAS, Wellington should not pick winners and losers, and
WHEREAS, taxpayer money should be spent on services to all residents.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF WELLINGTON, COLORADO OR THE REGISTERED ELECTORS OF THE TOWN OF WELLINGTON, COLORADO, THAT:

Section 1. A new section is hereby added to Article 3 of Chapter 4 of the Wellington Municipal Code and shall read as follows:

Sec 4-3-70 – Donations

The Town of Wellington shall be prohibited from giving monetary donations to individuals and nonprofit organizations.

Section 2. The Board of Trustees declares that, should any provision, section, paragraph, sentence or word of this Ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Ordinance as hereby adopted shall remain in full force and effect.

Section 3. All the provisions of the Wellington Municipal Code as heretofore adopted that are in conflict with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

Section 4. The Town Clerk shall certify the passage of this Ordinance and cause notice of its contents and passage to be published or posted. This Ordinance shall become effective immediately upon adoption or passage by the voters.
