## **Intergovernmental Agreements**



## Intergovernmental Agreements (IGA)

- An Intergovernmental Agreement (IGA) is:
  - A tool to establish how two or more governmental entities will work together
  - Authorized by Colorado State Statutes
  - Used by governments to cooperate to solve problems of mutual concern



## Intergovernmental Agreements (IGA)

- Purpose
  - Planning or regulating the development of land
  - Create mutually binding and enforceable plans for areas within the jurisdictions
  - Protect legislative powers of each jurisdiction
  - Promoting and achieving a shared vision



## Intergovernmental Agreements (IGA)

- Identify Specific Objectives:
  - Define decision-making authority
  - Implement a plan
  - Establish annexation policies
  - Define processes and procedures
  - Identify common standards
  - Establish financial responsibilities
  - Others

- Apply to a defined area:
  - Planning area
  - Intersection or transportation corridor
  - Neighborhood
  - River or stream corridor
  - Drainage basin
  - Others

## **Growth Management Area (GMA)**


- A Growth Management Area (GMA) is:
  - An area outside of a community's current boundaries where the community is likely to expand
  - A guide for future land use goals and strategies
  - Established through development and adoption of a Comprehensive Plan

- A GMA is <u>not</u> a regulatory tool
  - A GMA can become a regulatory tool if adopted as part of an IGA and terms of enforcement agreed to in the IGA



## **Growth Management Area (GMA)**


- Purpose:
  - Efficient extension and financing of municipal services
  - Avoid duplication of services
  - Implement local land use regulations
- Create clear expectations for:
  - Future land uses
  - Development pattern and intensity
  - Design and infrastructure standards
  - Town boundaries and annexation policies
  - Infrastructure maintenance and management







# Wellington Growth Management Area (GMA)

- Relationship to statutory 3-mile plan






## Fort Collins Growth Management Area (GMA)
