Be it enacted by the Town of Wellington:

#### **Ordinance Concerning Elections in the Town of Wellington**

WHEREAS Wellington is highly committed to election integrity, and WHEREAS, Wellington is committed to making elections secure; and WHEREAS, Wellington is committed to transparency and communication.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF WELLINGTON, COLORADO OR THE REGISTERED ELECTORS OF THE TOWN OF WELLINGTON, COLORADO, THAT:

Section 1. Section 10 of Chapter 2, Article 1 of the Wellington Municipal Code is hereby repealed in its entirety.

**Section 2**. Section 10 of Chapter 2, Article 1 of the Wellington Municipal Code is hereby replaced and shall read as follows:

#### Section 2-1-10 Conduct of Elections

- A. Elections shall be conducted in person at one or more polling places designated by the municipal governing body.
- B. Each polling place shall use paper ballots and the ballot tabulation shall be counted by hand and the count may be verified by a machine.

**Section 3**. A new section is hereby added to Chapter 2, Article 1 of the Wellington Municipal Code and shall read as follows:

#### Section 2-1-40 Notice of elections

It shall be the duty of the municipal governing body to give notice of all municipal elections by direct mail or flyer service to every elector in the town limits. The notice shall be delivered on or before 30 days preceding

the election, except where otherwise provided by law. The notice shall include all candidates and measures on the ballot, the date of the election, and the voting place address and hours of operation.

**Section 4.** The Board of Trustees declares that, should any provision, section, paragraph, sentence or word of this Ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Ordinance as hereby adopted shall remain in full force and effect.

**Section 5.** All the provisions of the Wellington Municipal Code as heretofore adopted that are in conflict with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

**Section 6.** The Town Clerk shall certify the passage of this Ordinance and cause notice of its contents and passage to be published or posted. This Ordinance shall become effective immediately upon adoption or passage by the voters.
